BACKGROUND:

As part of our ongoing professional development initiative and to meet the goal that "All students will demonstrate proficiency in ELA standards by 2014, a requirement of NCLB", Fontana Unified School District elementary teachers will be participating in an Elementary Reading Academy during December 5-9 2011 and January, 3-6 2012. The purpose of this academy is to highlight the research-based components that are required for a student to become a reader, the five big ideas in early literacy, and to link these ideas to our adopted programs: Open Court Reading, Read 180, and System 44. Additionally, the Elementary Reading Academy will allow teachers to better understand the rationale for utilizing DIBELS in our district, as it measures acquisition of the big ideas in early literacy. Our training goal is to have every elementary teacher well versed in these essential ideas to refine core instruction and provide targeted interventions in an effort to better serve the students in our community.

Topics to be covered at the Elementary Reading Academy include: Overview, Linguistics, and Early Literacy; Phonemic Awareness and Phonics; Multisyllabic Words and Fluency; Vocabulary; and Comprehension.

The Elementary Reading Academy is a follow-up to the Instructional Materials Professional Development (formerly known as SB472) that was previously offered by the District. This link from theory to practice will allow teachers to better meet the literacy needs of our students as identified by DIBELS.

**EMERGENCY RESOLUTION FOR
COMPLETION LANDSCAPING AND LANDSCAPING MAINTENANCE
(Sitework & Utilities–Category #2–Landscaping) at Citrus Continuation High School**

RESOLUTION NO. 11-100

WHEREAS, the Governing Board of the Fontana Unified School District (“District”) originally awarded a Contract for the landscaping work portion for the construction of Citrus Continuation High School Sitework & Utilities–Category #2–Landscaping (Bid No. 9/10-1324) (hereinafter referred to as “Project”) to Sierra Landscape Co., (“Sierra”).

WHEREAS, on or about August 20, 2009, the District and Sierra entered into a contract for the Project whereby Sierra was required to perform the landscaping scope of work on the Project.

WHEREAS, Sierra’s payment and performance bond surety on the Project is Great American Insurance Company (“Great American”);

WHEREAS, due to Sierra’s failure to provide all the services required by the Project contract, the District’s legal counsel issued a termination letter to Sierra dated April 26, 2011 providing Sierra and its surety, Great American, with the required notice of the District’s termination for cause of the Project contract in accordance with the terms of the contract documents;

WHEREAS, pursuant to the terms of the termination letter, Sierra was required to cure the issues raised in the District’s Notice of Termination within 72 hours of receiving the notice and has failed to either address or cure the issues raised in the District’s Notice of Termination;

WHEREAS, on May 19, 2011, the District formally terminated Sierra’s contract for cause and made formal demand on the surety, Great American, to fulfill its obligations under the performance bond and complete Sierra’s scope of work;

WHEREAS, Great American and the District have negotiated an agreement whereby Great American will tender a contractor (“Southern California Landscape, Inc.”) to complete Sierra’s scope of work on the Project;

WHEREAS, it would work an incongruity and not produce any advantage to the District to competitively bid completion of Sierra’s scope of work for the Project due to the immediate need to complete the Project and provide safe and adequate facilities;

WHEREAS, competitive bidding for the completion of work would entail significant delays to prepare plans and specifications detailing the exact state of the

Project and would further require at least an additional two weeks to advertise, award and contract for the services of a takeover contractor;

WHEREAS, Meakin v. Steveland (1977) 68 Cal.App.3d 490 and Los Angeles Dredging v. Long Beach (1930) 210 Cal. 348 holds that statutes requiring competitive bidding do not apply when competitive bidding would work an incongruity or not produce any advantage;

WHEREAS, Shore v. Central Contra Costa Sanitary District (1962) 208 Cal.App. 2d 465 and Garvey School District v. Paul (1920) 50 Cal.App. 75, further holds that a contract for takeover work may be exempted from competitive bidding upon termination for cause of the original contractor;

WHEREAS, in order to complete work on the Project and to minimize any damages to the work performed and danger to students, it is necessary to enter into a new contract or contracts for a takeover contractor for the Project;

WHEREAS, the Governing Board desires by a majority of the vote and pursuant to Education Code section 17604 and similar statutes, to delegate authority to the Associate Superintendent of Business Services the authority to execute any and all agreements and to complete all necessary documents to complete the Project, or to otherwise carry out the intent of this Resolution.

NOW, THEREFORE, BE IT RESOLVED that the Governing Board makes the following findings regarding the emergency which exists:

1. That the above recitals are true and correct.
2. That completion of work on the Project is necessary to immediately necessary to keep the Project on schedule and to avoid damages to the landscape work performed on the Project. Given the timing and the termination that occurred, there is inadequate time to assess the work, prepare drawings and rebid;
3. That under Shore v. Central Contra Costa Sanitary District the District may take over and complete work from SIERRA, a contractor that has been terminated for cause;
4. That it would work an incongruity and not produce any advantage to the District to competitively bid the Project.
5. That the District's Governing Board hereby approves the award of a contract to Southern California Landscape, Inc., to complete the work not completed and abandoned by Sierra.
6. That the District's Governing Board hereby approves the delegation of authority to its Associate Superintendent of Business Services or his designee, pursuant to a majority of the vote of the Governing Board and Education Code section 17604 and

similar statutes, to execute any and all agreements and to complete all necessary documents to complete the Project, or to otherwise carry out the intent of this Resolution, all subject to ratification of the Board of Education.

BACKGROUND:

At the July 13, 2011 Board of Education meeting, the Board unanimously approved the utilization of six unpaid furlough days by Superintendent Cali L. Olsen-Binks, Associate Superintendent of Business Services Alejandro Alvarez, and Associate Superintendent of Instructional Services Jose Oscar Dueñas, effective July 1, 2011 through June 30, 2012; for a cost savings to the district \$11,285.04. At the October 19, 2011 Board meeting, the Board restored three furlough days to Classified Bargaining Unit and Management employees, and 15 hours of furlough time to School Police Officers. Board Member Kathy Binks has requested an agenda item to restore three furlough days to the Superintendent and the Associate Superintendents, who are under individual employment contracts with the District.

During the process of accepting proposals for a Board attorney, it came to light that the current Board Bylaw 9124, Attorney, is very outdated. The CSBA sample bylaw was provided to the Board of Education members on October 14, 2011 for review and input regarding updating the existing FUSD bylaw. The attached bylaw reflects deleting the existing FUSD version and replacing it with language from the CSBA sample.

~~On request of the Governing Board, the county counsel will defend the district in any suit brought against it, without fee or any other charge, pursuant to Part 2 (commencing with Section 814) of Division 3.6 of Title 1 of the Government Code. The county counsel will likewise defend any member of the Board or any employee or servant of the district as provided in Part 7 (commencing with Section 995) of Division 3.6 of Title 1 of the Government Code. (Education Code 35203)~~

~~The Board may contract with the office of the county counsel for additional services, at a fee and in a manner agreed upon by the Board and the office of the county counsel. (Education Code 35206)~~

~~All requests for legal information from County Counsel or Attorney will be channeled through the Superintendent.~~

~~Attorney in Private Practice~~

~~The Board may appoint an attorney in private practice as an employee or independent contractor, or use an administrative adviser for whatever purpose the Board deems appropriate, and fix and pay such attorney according to the contract. The district shall first obtain the written views of the district attorney or county counsel as to the merits of any litigation and the form of the proposed contract of employment with the private attorney.~~

The Governing Board recognizes the complex legal environment in which districts operate and desires reliable, high-quality legal advice at reasonable rates. In order to meet the district's legal needs, the Board may contract with county counsel, attorneys in private practice, or appoint legal counsel as a district employee or independent contractor. The Board also supports pursuing collaborative legal efforts with other agencies and districts as appropriate.

Duties of Legal Counsel

The district's legal counsel may: (Education Code 35041.5)

1. Render legal advice to the Board and the Superintendent or designee

2. Serve the Board and the Superintendent or designee in the preparation and conduct of district litigation and administrative proceedings

3. Render advice on school bond and tax increase measures and prepare the necessary forms for the voting of these measures

4. Perform other administrative duties as assigned by the Board and Superintendent or designee

Retaining Legal Counsel

When the district is seeking legal advice or representation, the Superintendent or designee shall initiate a Request for Proposals (RFP) to advertise and solicit proposals for legal services. In evaluating the proposals, the Board and Superintendent shall consider the firm's or attorney's background, experience, and reputation in education law; experience advising or representing school districts in California; fees; and experience of attorneys at the firm who will provide legal services.

The Board and Superintendent shall annually evaluate the performance of the firm and/or attorneys providing legal services in such areas as efficiency and adequacy of advice; results obtained for the district; reasonableness of fees; and responsiveness to and interactions with the Board, administration, and community. Upon a successful evaluation, the Board may renew the agreement with legal counsel without initiating an RFP.

The Board may also contract for temporary, specialized legal services without initiating an RFP when a majority of the Board determines that the unique demands of a particular issue or emergency situation so requires.

Contacting Legal Counsel

At his/her discretion, the Board president or Superintendent may confer with district legal counsel subject to any limits or parameters established by the Board. In addition, the Superintendent or Board president may contact district legal counsel to provide the Board with legal information or advice when so directed by a majority of the Board.

Individual Board members other than the Board president may not seek advice from district legal counsel on matters of district business unless so authorized by a majority of the Board.
