DISCUSSION/ACTION SESSION

Denied the charter school petition to establish the New Vision Middle School #2.

Approved entering into a contract with Adelante Educational Services (AES) to provide an intervention program at Alder MS on Saturdays and during off-track Intersession from February 18, 2010 – June 30, 2010, amount not to exceed \$100,000.

Adopted the second reading of revised Board Policy 5123, Promotion / Acceleration / Retention.
