

NOTICE INVITING BIDS

NOTICE IS HEREBY GIVEN that the Board of Education of the Fontana Unified School District of San Bernardino County, located at 9680 Citrus Avenue, in the City of Fontana, will receive up to, but not later than **2:00 P.M.**, on the **17th** day of **November, 2009**, sealed proposals for the award of a contract for:

FONTANA HIGH SCHOOL POOL REPLASTER AND REPAIR Bid No. 09/10-1316R (Re-Bid)

A **MANDATORY JOB WALK** will be conducted on **Tuesday, November 3, 2009, promptly at 10:30 A.M.** Bidders or their representatives are to meet at the south campus gate at Fontana High School, 9453 Citrus Avenue, Fontana, CA 92335. **ONLY THOSE BIDDERS WHO ATTEND THE ENTIRE JOB WALK WILL BE ELIGIBLE TO BID THIS PROJECT.** There will be a sign-in and sign-out sheet at the job walk. If you attended the previous mandatory job walk on September 17, for Bid No. 09/10-1316, and signed the Sign In/Out sheet, you will not be required to attend.

Such bids will be received in the office of the Director of Purchasing, 9680 Citrus Avenue (**Bldg. #30**), Fontana, California. Each bid shall be made out on a form to be obtained with the bid package.

Each bid shall be accompanied by a certified or cashiers check, cash, or bid bond for five percent (5%) of the amount of the bid made payable to the Board of Education, shall be sealed in an envelope provided by the Fontana Unified School District and filed with the Board of Education on or before the aforementioned time and will be opened and publicly read aloud shortly thereafter on that day in the office of said Board of Education.

Said bond shall be given as a guarantee that the bidder will enter into the contract if awarded to him/her. In the event the bidder refuses to execute said contract, the use by the public of said structure(s) will be delayed and the public will suffer great damage. Therefore, the School District and the bidder agree that the above sum shall be paid to the School District under the conditions above set forth as liquidated damages and not as forfeiture.

Each bid must conform and be responsible to all the pertinent contract documents. Bidding documents for the project will be available after October 16, 2009, and may be obtained from the office of the Director of Purchasing, 9680 Citrus Avenue (**Bldg. #30**), Fontana, 92335. The plans/drawings will be available after the job walk on November 3, 2009 (there is no charge for these documents). The CONTRACTOR to whom the contract is awarded may avail him/herself of the provisions of Government Code Section 4590 which allows certain securities to be substituted for moneys withheld to ensure performance.

The District has obtained from the Director of the Department of Industrial Relations the general prevailing rate of per diem wages in the locality in which this work is to be performed for each craft or type of workman needed to execute this contract. Such rates are online at <http://www.dir.ca.gov/DLSR/PWD>. Contractor must be in possession of a current **B and C-53** contractor's license at the time of bidding.

The Board of Education reserves the right to reject any and all bids and waive any irregularities or informalities in any bid or in the bidding; and to accept or reject any items thereon. No bidder may withdraw his bid for a period of thirty (30) days after the date set for the opening thereof.
