INSTRUCTIONAL MATERIALS

Sufficiency of Instructional Materials

Fontana Unified School District held a public hearing on September 4, 2024, and adopted Resolution # 24-32 to certify that each school within the district had sufficient and good quality textbooks, instructional materials, foreign language materials, visual and performing arts materials, and/or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects, Foreign Languages, Health, and Visual and Performing Arts, for use in the classroom and to take home.

Adoption of Instructional Materials

Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the state are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption.

SCHOOL FACILITIES

Age and Condition of Facilities

West Randall Elementary School provides a clean, safe, and functional environment for learning through proper facilities maintenance and campus supervision. Built in 1947, the school sits on nine acres and includes a library, 19 permanent classrooms, 13 portable classrooms, a student support center, a staff lounge, a teacher's workroom, and a cafeteria. Ongoing maintenance by site custodians and district trade specialists ensures facilities remain up-to-date and provide adequate space for students and staff.

Campus Supervision

As students arrive on campus each morning, supervision is outside at the front entrance area, kindergarten entrance, blacktop lines, and cafeteria to monitor student behavior and activities. During morning recess, campus supervision aides monitor the playground areas. During lunch recess, campus supervision aides are assigned to the cafeteria and playground. We also have ELEVO coaches teaching students sportsmanship and other activities at the field area several times a week during recess and lunch. At the end of the day when students are dismissed, teachers are assigned to strategic locations in the student pickup area, bus loading zones, and at exit areas to ensure students leave in a safe and orderly manner. A crossing guard helps students safely cross the street before and after school. West Randall Elementary School is a closed campus. During school hours, all visitors must sign in at the school's office and wear identification badges while on school grounds.

Campus Maintenance

School custodial staff and the district's maintenance department work together to ensure playgrounds, classrooms, and campus grounds are well-maintained and kept safe and functioning for students, staff, and visitors. The Fontana Unified School District publishes a comprehensive custodial manual which outlines cleaning standards and prioritization guidelines. Each custodial staff member receives job training and is provided a copy of the district's cleaning manual which defines individual responsibilities regarding maintenance procedures, daily responsibilities, performance expectations, and safety measures.

One full-time day custodian and two full-time evening custodians are assigned to West Randall Elementary School and are responsible for keeping classrooms and facilities clean, safe, and in good repair and working order.

Each morning before students arrive on campus, the day custodian and campus supervision aides inspect facilities for graffiti, safety hazards or other conditions that need attention prior to students and staff entering school grounds. Restrooms are checked periodically throughout the day and cleaned as needed. The principal and custodians communicate regularly regarding campus maintenance and safety issues. Daily housekeeping and cleaning takes place in the evening. When students and staff are on school break, custodial teams focus on deep cleaning of carpets, floors, windows, restrooms, and other major components of the campus.

An electronic work order process is in place for non-routine school repairs and maintenance projects. School staff submit work orders to the school secretary who forwards all work orders to the district's maintenance department who identifies the scope of the project and then assigns the project to either district maintenance technicians/specialists or site custodians. Each site custodian is capable of handling general repairs; projects requiring specialists or third party contractors are completed by the district's maintenance department. Emergency repairs are typically resolved immediately by either school custodians or district maintenance specialists.

Improvements to Facilities

The following facility improvements are being made districtwide where necessary: wi-Fi infrastructure upgrade and technology upgrades, sidewalk replacement (on-site tripping hazards), portable ramp replacement, portable HVAC units for portable classrooms of various sites, re-sealing of MPR floor, solar installation projects, PA system upgrades, paint exterior of entire school, paint interior of entire school, replace/repair swamp coolers, replace intermittent failing HVAC units, replacement of portable siding and paint, replace ramps, general installation of TVs in classrooms.

Additionally, the following facility improvements are planned specifically for our school: B3 portable re-modeling and renovation.

Facility Inspection Results

Ongoing maintenance by site custodians and district trade specialists ensures facilities remain up-to-date and provide adequate space for students and staff. The district's maintenance department inspects facilities and operating systems at each school at least twice a year. A formal inspection report is prepared annually in accordance with Education Code §17592.72(c)(1). Fontana Unified School District uses the Facilities Inspection Tool developed by the California Office of Public School Construction to assess current conditions of the campus and identify facilities improvement needs.

PUPIL ACHIEVEMENT AND OUTCOMES

PROFESSIONAL DEVELOPMENT

All training and curriculum development activities at Fontana Unified School District revolve around the Common Core State Standards, including Next Generation Science Standards, Professional Learning Communities, 21st Century Learning and Multi-Tiered System of Supports. The schools supplement district training with site-based training focused on meeting the needs of the school, based upon student assessment results and teacher input. The district plans, implements, and evaluates professional development opportunities for administrators and teachers. Staff members are encouraged to attend district sponsored training and professional development programs.

All staff complete mandatory training online through Target Solutions annually. The mandated training covers the following topics: Child Abuse, Mandated Reporter Training, School Bullying, Anti-Harassment Training, Maintaining Professional Staff/Student Boundaries, Bloodborne Pathogens Safety, and Recognizing and Preventing Youth Suicide.

New and veteran teachers are offered support through Peer Assistance and Review and Induction programs. Each program pairs participating teachers with qualified mentoring teachers in order to gain skills and knowledge to be most effective in the classroom. Paraprofessionals receive specialized training to support current classroom curricula and effective instructional strategies. Classified support staff receive job-related training from department supervisors and district representatives.

Three days are dedicated annually to district-wide staff development. All school sites have early student-release days on Wednesdays for PLC meetings, Staff collaboration, teacher prep time and professional development. Additional professional development opportunities take place by releasing teachers from their classroom with substitutes. To ensure this doesn't impact the instructional program, every effort is made to limit teachers being released from their classroom for professional development to no more than five - ten days per school year. Teachers and classified staff are also offered additional optional professional development opportunities outside of their work day and during winter break, summer break, and Saturdays. Additional compensation is awarded for attendance in order to encourage staff to take advantage of opportunities available during non-contracted times.

ADDITIONAL INTERNET AND PUBLIC LIBRARY ACCESS

For additional research materials and Internet availability, students are encouraged to visit county and city public libraries, which contain numerous computer workstations.

DISCIPLINE AND CLIMATE FOR LEARNING

West Randall Elementary School's students conduct themselves responsibly and respectfully, minimizing the need for disciplinary action or intervention. Students are guided by school rules and behavior expectations established by the Fontana Unified School District and that promote respect, cooperation, courtesy, and acceptance of others.

School staff discuss the various types of appropriate and inappropriate behavior supplemented with the range of consequences for poor choices in conduct. A progressive discipline approach is taken when students are having difficulty following school rules. Administrators take into consideration past behavior trends when determining appropriate consequences. At the beginning of the school year, a discipline assembly is held for each grade level. All grades receive information about sexual harassment and no bullying policies. Students are reminded of school rules and behavior expectations as needed throughout the year at parent conferences, in classroom discussions led by teachers, and in conferences with the principal. In addition, West Randall Elementary school implemented Positive Behavioral Interventions and Supports (PBIS). This is a behavior support system that is designed by the school staff to meet the social and behavioral needs of the students. The focus of PBIS is to provide rewards to students who meet the school-wide expectations by exhibiting positive behavior. The expectations are: Be Safe, Be Respectful, and Be Responsible.

Every student has the opportunity to be recognized for outstanding academic efforts and demonstrating good citizenship. Students demonstrating good behavior are rewarded with PBIS Reward points which can be issued by any school staff member. Students use the points monthly to purchase an item from our online Paw-Mart store. Academic achievements are honored at end-of-semester awards assemblies, and certificates are issued for perfect attendance, academic achievement, exemplary PBIS expectation modeling, and Principal's Honor Roll. At the end of the year, the sixth grade promotion ceremony brings staff and parents together to celebrate students' efforts and the transition to middle school.

After-school programs promote academic enrichment and support. West Randall sponsors various enrichment activities during first recess and after school. The city parks and recreation department hosts the Fontana After School Program on campus which offers a supervised, structured environment for after-school activities.
