Board Member Binks commented that she would be remiss if she did not thank Mr. Alvarez and apologized for the embarrassment of having the item on the agenda again.

Superintendent Olsen-Binks thanked her Executive Assistant for clearing her calendar of all but the most important meetings and for supporting Mr. Alvarez during her absence. 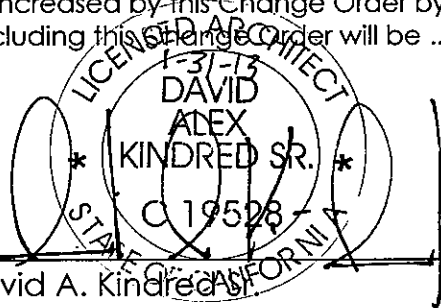



**BACKGROUND:**

The Fontana Unified School District utilizes the services of California School Boards Association for the maintenance of its policy manual. These services include tri-annual policy update packets to assist in keeping FUSD policies up-to-date, access to CSBA sample policies, and the GAMUT online service for posting policies on the Internet. In all there are roughly 750 CSBA sample policies. The district would not need all of them, but certainly would need most of them to update its policy manual.

The budget cuts over the past several years have forced the district to make staff cuts, thus reducing the number of employees available to review and revise policies. CSBA has offered to conduct a series of Policy Development Workshops at a discounted rate to assist in this process.

With PDW, one of the CSBA policy consultants will visit the district for three days. The consultant will facilitate the review and customization of the CSBA template policies by the district's policy review team, usually the Superintendent, cabinet, and Board representative(s). The draft policy manual generated at this meeting is then word processed by CSBA and returned for Board consideration and adoption. Once the manual is adopted, CSBA will provide a final copy of the new policy manual.

The cost of this service is based on a district's Average Daily Attendance. For Fontana Unified, with an ADA of 39,055, the regular price would be \$30,250.00. Because FUSD subscribes to GAMUT Online, CSBA can offer this service at a 50% discount; the price will be \$15,125.00; the district will also bear the consultant's travel costs.

**FISCAL IMPLICATION:**

\$15,125.00 plus consultant travel costs

**RECOMMENDATION:**

The Superintendent recommends that the Board of Education approve three Policy Development Workshops to be conducted by the California School Boards Association the week of June 11-15, 2012 in the amount of \$15,125.00 plus consultant travel costs.

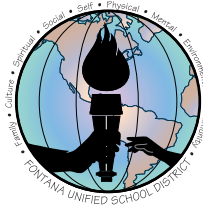
