I also know that many of our hard-working parents in our community don't have work schedules that closely match our school bell schedules. Afterschool programs provide an opportunity for students to supplement their learning, reinforce the daily lessons learned, and/or be physically active in a safe, supportive, and supervised environment.

When I taught in LAUSD, our middle school students had the privilege of participating in LACER (Literature, Arts, Culture, Education, and Recreation) Afterschool Programs.
