SHS PARKING RULES AND REGULATIONS

1. **This Parking Permit is for the North Parking Lot ONLY (Student Parking Lot).** I understand that this lot will be locked from 8:45 AM until 2:30 PM every day. If I need to leave for a pre-scheduled medical appointment, I will need to obtain a one day only pass for the south parking lot, the day prior to the appointment by bringing a note from my parent.
2. All Parking Permits expire at 4:00 P.M. on the last day of school.
3. Parking Rules are enforced during all normal school hours, including Zero and Seventh Period.
4. **A student parking permit limits parking to any stall designated for student parking only.**
5. Violations of the Fontana Unified School District and Summit High School Student Code of Conduct related to the use of your vehicle are in effect at all times. Such violations may result in a revocation of your parking permit as well as other disciplinary consequences. Examples of these violations include, but are not limited to, off-campus parking, reckless and/or unsafe driving practices, and closed campus violations involving the use of your vehicle.
6. The school system retains authority to conduct routine patrols of student parking lots and inspections of the exteriors and visible interiors of student automobiles on school property. The school system may inspect the interior of student automobiles whenever a school authority has reasonable suspicions to believe illegal or unauthorized materials are contained inside the automobile. Such patrols and inspections will be conducted without notice, without student consent, and without a search warrant. If I fail to provide access to the interior of my car upon request by a school official, I will be subject to disciplinary action and the revoking of my parking privilege.
7. The school is not responsible for the vehicle or its contents. I am advised to leave vehicle(s) locked at all times.
8. Once parked, I am not permitted to remain in the car or return to the parking lot during school hours without authorization from the administration.
9. The parking lot is a restricted area. There is to be no loitering or visitation in the parking lot without an administrator's permission.
10. The **"NO SMOKING"** or possession of tobacco products regulation also applies to the parking lot.
11. Tardiness resulting from not being able to find a parking space will not be excusable.
12. Parking Permits are nontransferable from student to student and all additional vehicles must be registered.
13. If I violate my provisional license restrictions (as outlined in section 12814.6 of the California Vehicle Code) I will have my parking privileges revoked for the remainder of the school year.
14. I understand that excessive late arrivals to school, excessive absences from school, or continued disciplinary infractions could cause my driving privileges to be revoked by the school's administration.
15. Parking at Summit High School is a privilege and may be revoked by administration for any reason.

Failure to adhere to the above conditions places your vehicle subject to a citation issued by FUSD police (Section 21113 (a) CVC), a revocation of your campus driving privileges, and other discipline consequences as outlined in the Summit High School Student Code of Conduct.
