ARTICLES OF UNDERSTANDING

The following dress code guidelines will be honored at the Homecoming Dance:

Appropriate attire: Homecoming is a semi-formal dance. It is appropriate for men to wear dress pants (not jeans), a shirt with a collar and a tie. Ladies would be appropriately dressed in a dress (NO STRAPLESS DRESSES), skirt and blouse, or pant suit. Homecoming may be held outside. Please plan accordingly. *****DRESS SHOES ARE MANDATORY TO ATTEND THE DANCE*****

Inappropriate attire for everyone includes: strapless dress and tops, revealing clothing including clothing where excessive cleavage is displayed, clothing cut down to the navel or below the top of the breast line, apparel that exposes the posterior, see through clothing, bare midriff, sagging pants, Jeans/Denim Pants, display of undergarments of any kind, clothing or jewelry that is sexually explicit, clothing or jewelry that would create animosity between groups, is gang-like in nature, or is offensive or dangerous to others.

I.) Modesty and "Good Taste" are the keys. When in doubt, please ask administrator's approval prior to attending the event or dance. II.) Students who are in violation will not be admitted and will not receive a refund. If you have questions regarding attire, please get prior approval from your administrator. **III.) *Dance movements and mannerisms must fall within the standards of social acceptability and good taste. Dancing commonly referred to as "Freak Dancing" or movements which depict private acts, are sexually suggestive or are a distraction or bothersome to others are not allowed. Physically dangerous dancing such as slamming or moshing is not allowed.*** **IV.)** At all school functions or activities any consumption or possession of a controlled substance or alcohol shall be punished by the exclusion from that activity and further activities sponsored by the Associated Student Body. The administrators/chaperones in charge have the authority to apply these rules. Students will also be subject to district disciplinary regulations including suspension and/or expulsion. Any infraction of the FUSD, and/or school rules and regulations, shall result in the student and/or guest's parents being contacted. The student and/or guest may be asked to leave with their parents. In some cases, violators may be subject to criminal prosecution. Students may be suspended pending an investigation of their infraction incident. Guests, who violate the aforementioned rules and are students, may be subject to school discipline as well as criminal prosecution procedures. Anyone not admitted to an event or removed from an event due to a violation of these rules will not be given a refund. **V.)** Parents give consent for the student to be photographed and photos posted online and in school publications. **VI.) Students must arrive at the dance no later than one hour after start time and cannot leave more than one hour before the end of the dance.**
